## **Commission Celebrates Leadership in Public Service**

High school interns provide water and sewer updates at event highlighting public service

The Springfield Water and Sewer Commission (Commission) celebrated leadership in public service with Mayor Domenic J. Sarno, Superintendent of Springfield Public Schools Dr. Sonia E. Dinnall, the Massachusetts Water Works Association (MWWA), and Veolia North America as part of the Pipeline Program Leadership Summit on Wednesday, July 30<sup>th</sup> at Forest Park.

The Commission's Pipeline Program is a work-based learning paid summer internship program that offers hands-on learning experiences and exposure to the variety of rewarding careers in the water sector – careers that deliver essential services to the public. Participating in the program are 12 high school student interns from Springfield representing 8 different high schools in Springfield.

As part of the interns' summer of learning and service, the Commission hosted the Pipeline Program Leadership Summit, where interns provided attendees with informational updates on the water and sewer systems. Their presentations covered progress on the new West Parish Water Treatment Plant currently under construction, upgrades at the wastewater plant, and information about the range of routine maintenance activities necessary to keep water and sewer systems in service 24/7.

A Pipeline Program internship is unique in that interns rotate through various Commission departments and support staff on activities and projects including Engineering, Watershed Protection, Wastewater Operations, Drinking Water Operations/Laboratory, Information Technology, Meters, and Water Quality. Interns also take MWWA's "How Water Works: An Introduction to the Drinking Water Industry." This course is a first step as part of the education and training required to earn drinking water operator licenses in Massachusetts. In addition, interns participate in enrichment activities including job skill building and networking at other water utilities and related industries to gain a better understanding of the wide spectrum of careers involved in the daily operations of water and wastewater systems.

"Through the Pipeline Program I have not only learned more about the wide variety of water sector jobs, which I never knew much about, but also the science and engineering and even forestry that goes on behind the scenes to provide my community with drinking water and sewer service," said **Pipeline Program Intern Jayden Barrera**, a rising senior at Renaissance School.

"I commend the Springfield Water and Sewer Commission for providing this valuable hands-on work experience in public service for our Springfield youth" **said Mayor Domenic J. Sarno.** "Water makes our city run, and is a key cornerstone to Springfield's economy and future. I hope to someday see these interns running our treatment

plants, fixing pipes in our streets, or working in our public buildings and facilities while pursuing satisfying careers that make a difference in their own community."

"As the Commission undertakes a much-needed generational reinvestment in our water and wastewater infrastructure, it's equally important that we invest in the future local workforce to operate, maintain, and someday lead these critical systems," said **Commission Chairwoman Vanessa Otero**. "The Pipeline Program is important because interns not only learn about opportunities in water, but gain hands-on experience, build their workplace skills, participate in a water workforce training program, and finish the summer with tools and resources to take the next step in pursuing their educational and career goals."

**Superintendent Dr. Sonia E. Dinnall** said, "Work-based learning internship programs are vital to our students' growth and future success. They help students explore opportunities and build tangible and marketable career skills. We're proud to partner with organizations like the Springfield Water and Sewer Commission to support opportunities that connect classroom learning to real-world careers."
